Re: Standard Approved Study Center Agreement

Greetings in the name of our Lord and Saviour Jesus Christ.

In the following list, "SLBC" is used to designate Salt Lake Bible College. The term "ASC" will designate the school seeking certification as an Approved Study Center.

- 1. The only Bible used will be the KJV for English speaking schools or an equivalent in the language used in the school. All foreign language Bibles used must be translated from the Received Text.**
- 2. All ASCs that use SLBC materials must teach the courses exactly as written in the material. If they choose not to follow SLBCs material exactly as written in any particular course, then they must agree to not use any of SLBCs material in that particular course. Exact Translations into other languages are allowed.**
- 3. There can be no involvement by the school in any unscriptural practices concerning church establishment, polity, ordinances, spiritual gifts, and separation.**
- 3. The ASC will meet all financial obligations to SLBC.**
- 4. The ASC will send regular reports as required by SLBC.**
- 5. After the initial approval, ongoing yearly certification will be for one (1) year and will be dated from September 1st of one year to August 31 of the following year.**
 - a. A request for recertification must be submitted by the affiliate each year.**
 - b. When that request is received by SLBC, then a letter of recertification will be sent to the affiliate assuming that the ASC has continued to meet all requirements and obligations to SLBC.**
- 6. In the event of an infraction on the part of the ASC, the board of SLBC will send notice to the school with an invitation for their representative to come to SLBC and explain and/or send a written explanation for review by the board of SLBC.**
- 7. If, upon review by the board of SLBC, it is decided that any of these requirements are not being met, SLBC will request that the ASC return its certification. Upon such a request, the ASC agrees to return the Study Center Certificate to SLBC immediately.**
- 8. The affiliate agrees to these current requirements and any future requirements that SLBC may deem necessary from time to time and signifies its agreement with the signature of the ASC's authorized representative.**
